If a person or public body that files an appeal of a decision of the Township of Warwick Land Division Committee in respect of the proposed consent does not make written submission to the Township of Warwick Land Division Committee before it gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss the appeal.

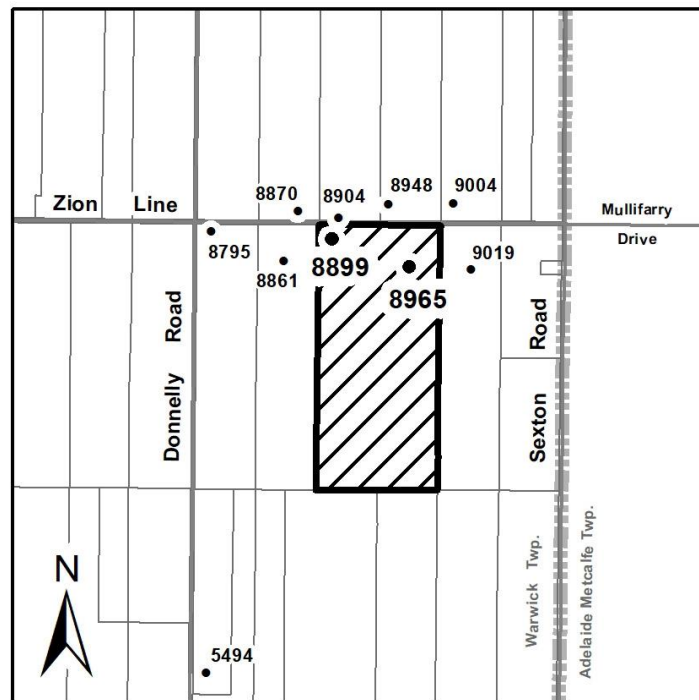
